

## World Cup 2023 Dressage Trip Sweepstakes Official Rules

**1. Introduction:** Equine Network, LLC (d/b/a Dressage Today (“Sponsor”) is offering the World Cup 2023 Jumping Trip Sweepstakes (“Contest”). NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

**2. Eligibility:** Entrant must be eighteen (18) years of age or older as of November 1, 2022 (or age of majority in state of residence) and a resident of the fifty (50) United States and the District of Columbia. Employees of Sponsor or Prize Provider, immediate family (defined as parents, spouse, children, siblings, grandparents) of each such employees, subsidiaries, affiliated companies, agents and all those with whom such employees are domiciled are NOT eligible.

Limit one [1] entry via an official entry form per participant. All required information/fields must be fully, accurately and legibly completed or entry may be voided. Contestants may enter once (1 time per person) during the Contest period. More than one (1) entry from any person or email address during the Contest period will void all entries from that person or email address.

Sponsor is not responsible for late or incomplete entries. If a problem occurs in the online submission process, Entrant should receive an “Error” message.
